#### CONVERSION AGREEMENT

ECS Federal, LLC (Contractor), a limited liability company duly organized and existing under the laws of the State of Delaware with its principal office in Fairfax, Virginia, formerly ECS Federal, Inc., a corporation incorporated under the laws of the State of Florida, and the United States of America (Government) enter into this Agreement as of March 24, 2015.

(a) The parties agree to the following facts:

(1) The Government, represented by various Contracting Officers of the agencies shown in the attached list marked "Exhibit A", has entered into certain contracts and purchase orders with ECS Federal, Inc., as shown in the attached list marked "Exhibit A" and incorporated in this Agreement by reference. The term "the Contracts," as used in this Agreement, means the above contracts and purchase orders and all other contracts and purchase orders administered by DCMA or for which DCMA has been delegated authority to include in this Agreement, including all modifications, made by the Government and the Contractor before the effective date of this Agreement (whether or not performance and payment have been completed and releases executed if the Government or the Contractor has any remaining rights, duties, or obligations under these contracts and purchase orders).

(2) ECS Federal, LLC, by a Certificate of Conversion filed on March 24, 2015, with the Secretary of State of the State of Delaware, converted to a limited liability company formed under the laws of the State of Delaware from a corporation incorporated under the laws of the State of Florida and changed its name to ECS Federal, LLC, effective March 24, 2015.

(3) The conversion resulted in the Contractor converting from a Florida corporation to a Delaware limited liability company and changing its name only. All rights and obligations of the Government and the Contractor under the Contracts are unaffected by these changes.

(4) Documentary evidence of the conversion and name change has been provided to the Government.

(b) In consideration of these facts, the parties agree that:

(1) The Contracts are amended by substituting the name ECS Federal, LLC, for the name ECS Federal, Inc., wherever it appears in the Contracts.

(2) Each party has executed this Agreement as of the day and year first above written.
